The Researcher selected 3D framework that was proposed by Norman Fairclough(1992). 3D framework introduced three aspects for the critical analysis of any discourse or text to be analyzed. They consists of text, socio-cultural practices and discursive practices in a society. Text is analyzable as socio-economic and political factors influence the discursive practices in the society. According to (N. Fairclough London) described the objective of this approach as a contribution to the general rising of consciousness of exploitative social relations, through focusing upon language.

#### Extract 1

..... "One hundred years later, the life of the Negros still sadly crippled by the manacles of segregation and the chains of discrimination" (King 1963).

...... "One hundred years later, the Negro lives on a lonely island of poverty in the midst of a vast ocean of material prosperity" (King 1963).

In extract 1, "one hundred years later" has been repeated four times. It clearly indicates that there has been a long time for African-Americans aspire for the freedom and equal rights without any discrimination based on color and creed.
