The Patriot, a historical drama directed by Roland Emmerich and written by Robert Rodat, stars Mel Gibson, Chris Cooper, and Heath Ledger (Aminatun, 2021), (Amelia & Daud, 2020). This unusual story takes place during a time when the interests of the state were at risk during a war (Qodriani & Wijana, 2021), (Arpiansah et al., 2021), necessitating that ordinary people provide energy as a form of support (Choirunnisa & Mandasari, 2021), (Wahyudin, 2018).

In accordance with Campbell's book, postmodern and poststructuralist philosophy have acknowledged various types of knowledge and techniques (Asia & Samanik, 2018), (K. Sari & Pranoto, 2021), and they started from the perspective of distrusting any "meta" or "great narratives," (Mandasari, n.d.), (Samanik, 2021) that is, those totalizing stories that claim to speak for all and explain everything (Novanti & Suprayogi, 2021), (B. N. Sari & Gulö, 2019). One way to read America as a constrained and "closed" text through a guiding metanarrative or "master-story" is to claim that America is exceptional and that its history was divinely decreed and destined to follow a defined trajectory (Pranoto & Suprayogi, 2020a), (Putri & Aminatun, 2021), (Fakhrurozi & Adrian, 2021). This debunking of the nineteenth-century myth of Columbus is significant because it demonstrates the strong connection between the reading and rewriting of American history (Qodriani, 2021), (Suprayogi, Pranoto, et al., 2021) and the resuscitation of interest in racial and ethnic minorities (Yulianti & Sulistyawati, 2021), (Fithratullah, 2019). Additionally, it is notable in that it highlights some of the issues that arise when one myth is refuted only to be replaced by another (Gulö et al., 2021), (Yulianti & Sulistiyawati, 2020), (Afrianto et al., 2021). In some ways, the dispute over the purposes of history is at stake here (Mertania & Amelia, 2020), (Yunara & Kardiansyah, 2017). Some of the Columbus debate participants believed that through revising the Columbus myth, the "truth" would surface, as if there was a correct account of his life and its consequences once falsehoods had been eliminated (Pranoto & Suprayogi, 2020b), (Gulö, 2018a). For

instance, one can learn a lot about identity inconsistencies and how they are essential to any image of "America" from Nick Carraway's story of Jay Gatsby (Mandasari & Oktaviani, 2018), (Muliyah et al., 2020). Similar to how Nick creates a history of Gatsby through the telling of his story; each generation has created and reinvented America (Sinaga & Oktaviani, 2020), (Samanik, 2018). On one level, Nick's tale reinforces the notion of a new beginning, which is one of the founding myths of American civilization (Puspita & Pranoto, 2021), (Hutauruk & Puspita, 2020). In the case of Gatsby, Nick tells us, he 'sprang from his Platonic conception of himself' (ibid.: 105), that is, a self-making process in which 'he invented just the sort of Jay Gatsby a seventeen-year-old boy would be likely to invent', full of hope and 'romantic readiness' (ibid.: 8). In 1980, Ronald Reagan spoke too of how 'we built a new breed of human called an American' (quoted in Bercovitch and Jehlen 1986: 26), as if to invoke the idea of self-creation as a core myth of American identity. Nick begins to see Gatsby as an embodiment of comparable American ideological ideals (Al Falaq et al., 2021), (Nurmala Sari & Aminatun, 2021), (Oktaviani, 2021), and by using him, he writes his own "history" of the country. However, the story is distinguished by its complexity, ambiguities, and contradictions. Some of the important qualms and questions we bring to any discussion of America and American identity become apparent as we read Nick's story.

Benjamin Martin, a former American soldier who now resides in the South Carolina region, serves as the film's historical foundation for this investigation. This film is categorized as social history because the main character, Benjamin Martin, is merely a former soldier who works as a farmer without any political influence.
